## ***1162<sup>nd</sup> meeting, February 27, 2013***

### **Dan Hipple then presented his talk, *Coinage of the White Rajahs of Sarawak*.**

James Brooke became the first rajah of Sarawak following his communing to the aid of the Sultan of Brunei. James helped put down a rebellion. His first coin, a one keping is rare and counterfeits are known. His nephew, Charles Johnson who took the name Charles J. Brooke succeeded him as rajah in 1868. Charles issued various denominations as needed throughout his tenure from 1868 to 1917. Charles son, Charles V. Brooke, succeeded his father in 1917 and served until 1946. He continued the coinage as needed. With the exception of the first keping coin, the series can be completed with some work.

#### ***Exhibits included:***

Bill displayed a proof engraving of the California State Seal made by the National Bank Note Co and three early tokens with the California State Seal.

Ed displayed the 2012 U.S. silver proof set from San Francisco.

Scott shared four Peruvian coins: the 1757 one half real and 8 reales and the 1758 one half real and 8 reales.

Michael shared a large silver octagonal medal produced for the 1930 San Francisco Chamber of Commerce.

David shared the last Great Britain decimal issue and miniature coins.

Michael shared two silver dollars, the 1883 and 1885 Os (New Orleans mint).

### **2013 Annual Papers Contest (abridged summary of rules, see last issue or the website for a full set of the requirements):**

PCNS is accepting entries for its 2013 Papers Contest. Submissions must be previously unpublished original writing on a numismatic topic. Participation is open to all. You do not need to be a PCNS member to participate.

#### **Contest Rules:**

1. Only original, previously unpublished writings on numismatic topics may be submitted. All submissions will be considered. Participants may submit more than one paper.

2. Format: Papers may be electronically submitted as either a plain text file or an MS Word doc file. Participants who lack electronic access should contact the society for other arrangements. See “Contacts” at bottom of this document.

3. Cover page: Papers should include (on a title page) the title of the paper, authors’ name(s), address, phone number and email address (for contact, not for publication).

4. Illustrations: All illustrations (photos, charts, tables, drawings, etc.) which are appropriate for publication should accompany the text, complete with any captions or descriptions which are needed for their interpretation and understanding by readers. Notes within the text should indicate where illustrations are placed (e.g. figure 3 here). Information on the original size of numismatic items should be included to aid in the publication of illustrations. Do not submit your images embedded in a text or Word file or the body of the paper. Images must be separate files for us to manage for publications.

6. Length of papers is not specific, but generally papers should be at least two double-spaced pages of type (not counting title page, illustrations, and bibliography). Longer papers are acceptable, but writers who are contemplating papers in excess of 12 double-spaced pages of text are cautioned that space limitations may affect our ability to publish it in a printed format.

7. Deadline for submissions of papers for the 2013 papers contest should be submitted by the April 24th, 2013 PCNS regular meeting.

8. Judging will be done by a panel of at least three judges selected by the Papers Chairperson. Judges will be directed to consider the following in making their recommendations: (a) contribution to numismatics, (b) clarity, and (c) interest.

10. Publication Rights. PCNS obtains all rights to publication and distribution of submissions. The material may not be under consideration for publication elsewhere, and may not be offered for publication elsewhere while PCNS has publication rights.

11. Copyright: By submitting material to PCNS for publication, the author is stating that no copyright restriction exists on any of the material, including photos, drawings, or illustrations of any kind.
