**April 2019 Minutes**

The board meeting for April 24, 2019 was called to order at 7:00 pm at Fort Mason by Vice President Jason Macario. Present were Treasurer Stephen Huston, Governor Ed Treuting, Secretary Bob Somers, Past President Bill Hyder and guest Debbie Hyder. President Dan Hipple sent his regrets.

The minutes from the March meeting were approved.

The first quarter financial report for period 01/01/19 to 03/31/19 was reviewed and accepted.

A new member application was received from Schuyler Rumsey and membership holds steady at 41.

Bill presented his recent research on The Other Continental Dollar. The restrikes and replicas possibly produced around 1861 or 1862 possibly using dies created by Robert Lovett Jr. Montroville Dickeson's American Numismatological Manual indicates they were struck as medals to commemorate the bold, fearless and patriotic acts of Congress in and around the civil war. Others propose they were struck to be sold for the 1876 Centennial Expo.
