**BOOK REVIEW:

1175th meeting, March 26, 2014

Michael Wehner presented his talk: *San Francisco Gold Rush Tokens.*

The earliest San Francisco tokens are generally identified as those of the Joseph Brothers and N.J. Hyman, similar pieces in style and fabric. Michael used early city directories, newspapers, and other published reports to answer the question to his satisfaction.

While the dates of businesses appearing on tokens can be determined with some precision from the original sources, the exact date of actual token manufacture and use cannot be precisely determined. Addresses mentioned on tokens can restrict the date range when they are used.

Excluding the token that inspired his search, the earliest San Francisco pieces are J. T. Jones countermarked pieces from the Blue Wing Saloon circa 1852-1856. The most interesting example of the countermark is found on an 1851 U.S. Assay Office Humbert \$50 gold slug. Bernhart & Jacoby pieces likely date to the same 1852-1856 period. The Joseph Brothers pieces would come next in the 1854 to 1860 period. The N. J. Hyman—who worked for the Joseph Brothers at one point—probably date to the 1870s. Other identified early pieces are all post 1860.

Michael focused on one piece tentatively assigned to San Francisco or Latin America, the Mauduit & Comp. half dollar token for the Cercle de San-Francisco. Michael found a July 1850 article in *Household Words, A Weekly Journal* edited by Charles Dickens reporting on a proposed French gambling establishment planned for to open in San Francisco on December 31, 1850. It is likely the business opened in 1851 even if it did not survive long making the token the earliest recorded for Gold Rush San Francisco.

Ed shared the 2013 limited edition San Francisco silver proof set.

Jerry shared a uniface cent with the question as to whether it was a mint error or an actual uniface cent. Actual uniface pieces will exhibit a wavy, convex, or concave surface and flow lines from the pressure. Jerry's piece

had parallel lines indicating it was a planed surface for inserting into a magician's nickel.

Scott exhibited an MS66RD Katanga 1961 1 Franc and an MS64RD 5 Francs.

Lew exhibited seven western tokens including a Buffalo Bill souvenir from Cody, WY; a slot machine token; Green River Whiskey token; and a 1910 Ohio River Valley Exposition medal.

Chris shared a high relief medal with the bust of Handel manufactured by Pinches of London.

Carl shared sets of Buffalo Nickels and Lincoln Cents.

Bill exhibited a silver-plated example of the 1896 NSGW Stockten Admissions Day medal and an 1894 National Guard of California Marksman Badge.
